Subject: Community Racial Profiling Commission Quarterly Report
(October - December 2007)

The Community Racial Profiling Commission (CRPC), established in November 2004, continued to fulfill its mission to serve as an advisory body to the City Council regarding bias free policing. This fourth quarterly report of 2007 describes the activities of the CRPC from October to December 2007.

Commission Membership

The following table depicts the fourth quarter status of Commission membership. Chair Ernest Carter ended his year of service to the Commission, and At-Large member Crystal Taylor was elected Chair for 2008. The Commission's Vice Chair, Deputy Chief Steve Segura, retired from the Sacramento Police Department after 30 years of service to the public. Deputy Chief Brian Louie will replace DC Segura as Vice Chair in 2008. Daniela Lopez-Garcia joined the Commission as representative for District 5. Brent Meyer, Sacramento Police Officers Association President, joined the Commission as Standing Member representing the SPOA.

The Mission of the Community Racial Profiling Commission is to serve as an advisory body of our community regarding bias free policing.

Since the last quarterly update, the Commission has experienced and accomplished the following:

Discussion on Lamberth Workshop and the Vehicle Stop Study Release –

Commission members:

- ❖ Shared impressions of the Lamberth workshop, held at the September 22, 2007 CRPC meeting, noting the diversity of perspectives of the traffic stop racial profiling issue;
- ❖ Discussed how the Lamberth study results will be presented to the City Manager, the Commission, the City Council, and the community;
- ❖ Determined that the Commission will prepare a written report on the study results;
- ❖ Noted that a communication specialist will be working with the Commission to produce the written report and facilitate their interactions with the City Council and the community.

Presentation/Workshop with Communication Specialist Michele McCormick –

Michele McCormick of MMC Communications led a discussion on effective community outreach following release of the Lamberth racial profiling study results, focusing on:

- ❖ Identifying key community stakeholders;
- ❖ Identifying key information to convey to the public about the study methodology;
- ❖ Identifying materials to provide to the public to aid understanding;
- ❖ Identifying Commission needs in communicating the study results.

Operational Update on Sacramento Police Department Activities–

Deputy Chief Steve Segura briefed Commission members throughout the quarter on Police Department activities and programs that could affect the frequency, location, or focus of traffic stops during the study period.

Goals –

Commission members continue to contemplate and discuss the dimensions of their purpose and their powers and duties in serving as an advisory body to the City regarding vehicle stop data collection, analysis processes and interpretation, and vehicle stop study release procedures. The Commission meets and counsels regularly with Lamberth Consulting and has worked with Communication Specialist Michele McCormick to ensure that the design, implementation, and release of the traffic stop study result in an accurate report on the status of vehicle stops in the city of Sacramento.
